Memorial Homoeopathic Medical College and Hospital, East Ramkrishna Nagar, Patna, Bihar-800027 for admission in B.H.M.S. course with intake capacity of 100 and M.D. (Hom.) course with intake capacity of 42 seats in 07 subjects namely, Homoeopathic Materia Medica, Homoeopathic Repertory and case taking, Homoeopathic Pharmacy, Organon of Medicine, Practice of Medicine, Paediatric and Psychiatry with 06 seats each for academic year 2026-27- reg.

Sir/Madam,

G.D. Memorial Homoeopathic Medical College and Hospital, East Ramkrishna Nagar, Patna, Bihar-800027 has submitted an application for permission in BHMS course with intake capacity of 100 seats and M.D. (Hom.) course with intake capacity of 42 seats in 07 subjects namely, Homoeopathic Materia Medica, Homoeopathic Repertory and case taking, Homoeopathic Pharmacy, Organon of Medicine, Practice of Medicine, Paediatric and Psychiatry with 06 seats each for the academic year 2026-27. The Medical Assessment and Rating Board (MARBH) conducted inspection on 22.05.2026 and 23.05.2026, followed by hearing on 03.07.2026. MARBH has examined the college to ascertain whether the college fulfils the Minimum Essential Standards as per the regulations in force. On careful examination of the report, MARBH observed the following shortfalls:

- a) **Hospital Functioning:** NABH/NABL accreditation is under process.
 - b) **Salary:** Salary of teaching, hospital and non-teaching staff is not as per MES, 2024.
2. Considering the above observations during inspection and hearing, MARBH has decided to issue **conditional permission to G.D. Memorial Homoeopathic Medical College and Hospital, East Ramkrishna Nagar, Patna, Bihar-800027 for admission in BHMS course with intake capacity of 100 seats and M.D. (Hom.) course with intake capacity of 42 seats in 07 subjects namely, Homoeopathic Materia Medica, Homoeopathic Repertory and case taking, Homoeopathic Pharmacy, Organon of Medicine, Practice of Medicine, Paediatric and Psychiatry with 06 seats each for the academic year 2026-27 on the basis of following conditions:**
- i. Hospital shall be functioning as per Second Schedule of National Commission For Homoeopathy (Minimum Essential Standards For Homoeopathic Colleges And Attached Hospitals) Regulations, 2024
 - ii. Salary of teaching, hospital and non-teaching staff shall be as per First Schedule of National Commission For Homoeopathy (Minimum Essential Standards For Homoeopathic Colleges And Attached Hospitals) Regulations, 2024

Deficiencies mentioned above should be rectified within a period of 30 days and the compliance report must be submitted to the undersigned, failing which conditional permission issued will be withdrawn without further notice

3. All admissions shall be made from NEET/AIAPGET qualified candidates only. It is further informed that minimum 15% of undergraduate seats and 15 % of postgraduate seats of the permitted intake capacity of UG/PG seats shall be treated as All India Quota. Counselling for seats under all India quota shall be conducted by respective Counselling Authority of State/UT Government as designated by Central Government and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counselling authority of the state/UT Government.
4. The Category-wise list of the selected candidates may be informed to the Medical Assessment and Rating Board after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board
